NOTICE is hereby given that sealed bids are invited and will be received by the Borough of Spring Lake Heights, Monmouth County, New Jersey as set forth herein.

PROJECT TITLE: SPRING LAKE HEIGHTS COMMUNITY CENTER ADDITION

GENERAL DESCRIPTION: The project generally consists of a base bid including bathroom renovations, new flooring and a generator, alternates include kitchen renovations, egress hallway, closets and a multipurpose room addition.

CONTRACT DOCUMENTS: Contract Documents may be examined, and may be obtained upon payment of SEVENTY-FIVE DOLLARS (\$75.00) for each individual set, Monday through Friday except legal holidays from 9:00 AM to 4:30 PM at the Municipal Building, 555 Brighton Avenue, Spring Lake Heights, NJ 07762.

BID SECURITY: Bid Security is required in an amount not less than ten percent (10%) of the total amount of the Bid, but not in excess of Twenty Thousand Dollars (\$20,000.00) as set forth in N.J.S.A. 40A:11-21. **Should a bidder provide both Alternates the LOWER Bid Amount is to be utilized to calculate the required Bid Bond.**

CONSENT OF SURETY: Certificate from a Surety Company is required indicating consent to be bound as surety and guarantor for performance required under the Contract Documents.

REQUIRED REGISTRATION: Bidders are required to be registered by the **New Jersey Department of Labor** at the time bids are received pursuant to the Public Works Contractor Registration Act (P.L. 2003, c. 91, N.J.S.A. 34:11-56.51). Bidders are also required to be registered by the **New Jersey Department of Treasury, Division of Revenue** at the time bids are received pursuant to the Business Registration Act (P.L.2004, c.57, N.J.S.A.52:32-44).

STATUTORY REQUIREMENTS: Bidders are required to comply with applicable statutory requirements set forth in the Contract Documents including the requirements of N.J.S.A. 10:5-31, et seq. & N.J.A.C. 17:27-1.1, et seq. (Affirmative Action); P.L. 1963, c. 150 (Prevailing Wage); Americans with Disabilities Act of 1990 (42 U.S.C. 12101, et seq.); and P.L.2004, c.19 & P.L.2005, c.271 (Pay to Play).

REJECTION OF BIDS: The Borough of Spring Lake Heights reserves the right to reject any or all Bids, or to waive any Bid defect where such defect is not detrimental to the best interest of the Borough and fairness of the bidding process. The right is also reserved to reject any and all bids if it is determined they do not meet the intent of the specifications in the Contract Documents. The right is also reserved to increase or decrease the quantities specified in the manner designated in the Contract Documents.
