

BOROUGH OF SPRING LAKE HEIGHTS

ORDINANCE NO. 2015-07

AN ORDINANCE AMENDING AND SUPPLEMENTING SECTION 7-6.3, ENTITLED “YIELD INTERSECTIONS” OF CHAPTER VII (TRAFFIC) OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF SPRING LAKE HEIGHTS, NEW JERSEY

WHEREAS, the Borough Engineer has recommended the establishment of a dedicated traffic lane for eastbound vehicles on Ocean Road to turn right onto southbound Old Mill Road within the Borough, and has further recommended that this right-turn lane be designated as a yield intersection; and

WHEREAS, the Mayor and Borough Council have determined it appropriate to provide for such right turn traffic lane and to amend and supplement the traffic regulations in section 7-6.3 entitled “Yield Intersections” of Chapter VII (Traffic) of the Borough Code as set forth herein.

NOW, THEREFORE, BE IT HEREBY ORDAINED, by the Mayor and Borough Council of the Borough of Spring Lake Heights, in the County of Monmouth and State of New Jersey, as follows:

SECTION 1. Section 7-6.3 entitled “Yield Intersections” of Chapter VII (Traffic) of the Revised General Ordinances of the Borough of Spring Lake Heights, New Jersey is hereby amended and supplemented together with “Schedule IX. YIELD INTERSECTIONS” in the following respects (additions are indicated by double underline; deletions are shown by ~~strikeout~~):

7-6.3 Yield Intersections.

Pursuant to the provisions of N.J.S.A. 39:4-140, the intersections described in Schedule IX attached to and made a part of this chapter are hereby designated as Yield Intersections. YIELD signs having sides thirty-six (36) inches in length shall be installed as provided therein.

SCHEDULE IX. YIELD INTERSECTIONS

In accordance with the provisions of subsection 7-6.3, the following are designated as Yield Intersections:

Name of Streets

Location of Signs

Shore Road and Jersey Avenue

A yield right-of-way sign shall be installed on Jersey Avenue.

Ocean Road and Old Mill Road

A yield right-of-way sign shall be installed on the right turn lane on Ocean Road.

SECTION 2. The provisions of this ordinance shall be severable. If any section or provision shall be held invalid by any Court of competent jurisdiction, the same shall not affect the other sections or provisions of this ordinance, which shall remain in full force and effect.


SECTION 3. All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistencies.

SECTION 4. The Borough Clerk is directed to forward a certified copy of this ordinance to the New Jersey Commissioner of Transportation within thirty (30) days of adoption pursuant to the requirements of N.J.S.A. 39:4-8.

SECTION 5. This ordinance shall take effect after final passage and publication in accordance with the law and upon approval of the New Jersey Commissioner of Transportation.
