### **Executive Session.**

Mr. Delaney reported on the status of discussions with the Board of Education on a recreation facilities shared service agreement. Borough Attorney Kenneally reported on the legal requirements for utilizing funds from the open space trust fund for recreation improvements to school facilities.

**APPROVAL OF MINUTES.** There were no minutes presented for approval.

**PRESENTATIONS.** Borough Administrator Delaney reported on the status of the Monmouth County Hazard Mitigation Plan update.

**PUBLIC HEARING - ORDINANCE NO. 2014-05,** AN ORDINANCE AMENDING CHAPTER 22 (MUNICIPAL LAND USE REGULATIONS) TO PROVIDE FOR RESIDENTIAL BUILDING HEIGHTS IN FLOOD ZONES

- Kimberley Frazier, 714 Shore Road commented on the Planning Board's recommendation to limit the first floor level to no more than three feet above the flood requirement and requested the ordinance permit the first level be high enough to provide non-livable space. Mr. O'Brien expressed support for providing flexibility to homeowners in the flood zone provided the building height of 37 feet is not exceeded.
- Eileen Eilenberger, Planning Board member, stated the Board's recommendation is intended to make certain the 32' height is maintained unless the home is being raised.
- Peter Cavagnaro, 2424 Hamilton Avenue identified himself as a friend of Ms. Frazier, thanked the Council for addressing this issue, and stated support for removing the 3' separation requirement.

Based on the comments from the Council, Borough Attorney Kenneally suggested the ordinance be amended to include the follow minor addition:

One-family detached dwellings. The maximum building height for principal structures in all residential zones shall be thirty-two (32) feet, as measured from the top of the curb at the center of the lot. The maximum building height for principal structures in Flood Insurance Rate Map (FIRM) Flood Zones shall be thirty-seven (37) feet for structures that are being elevated or newly constructed to meet flood zone construction guidelines.
