Attorney McLean replied that if you have a No Trespassing sign posted on your property or you're on the No Knock List, people have to observe that and if they don't, you need to call the police. Officer Ramp was in the audience; he concurred. Ms. Murphy asked what if someone is injured on your property will canvassing. Attorney McLean replied that this couldn't be addressed at this time. Officer Ramp stated that he would supply a copy of the statue.

PUBLIC COMMENT (Any item)

Kat Crippen 564 Atlantic Ave Asked if the Public Works Yard is going to be expanded. She heard from neighbors who stated that the property was surveyed and that the surveyor stated that it was going to be storage for construction debris. Mr. Delaney replied that the survey was done in conjunction with the ongoing site remediation from a spill at the location. Mr. Delaney added that the bond ordinance included funding for some building improvements, nothing is going to be expanded. Ms. Crippen thanked whomever was responsible for parking the DPW trucks to the back of the property.

George Corbeels 6 Nadine Drive thanked Public Works for the prompt pickup of the brush today from the weekend storm. He stated that he had been misquoted by the Coast Star about the Evergreen Inn. Mayor O'Brien asked if he wanted to clarify now, Mr. Corbeels stated no. He stated that a manhole cover on Wall Road, close to Rt. 71 needs repair, the cover is tilted. He asked who is responsible for the maintenance of Polly Pod in Spring Lake Heights. Mayor O'Brien invited Kat Crippen from the Environmental Commission to explain. She stated that it is in Spring Lake Heights and that in order to gain access we need permission from the owner of the shopping center. Mr. Diver added that the shopping center parking lot floods. Mr. Corbeels feels that in the winter SMRSA dumps treated water into it. Attorney McLean responded that he didn't believe that SMRSA dumped into it. Mr. McLean offered that Mr. Corbeels could call them directly. Mr. Corbeels feels that the Borough should address this. Mr. Delaney stated that post Sandy the area was cleaned from Highway 71 to the railroad. He added that he would look into the area that is Borough owned. Mr. Corbeels asked about a sidewalk across the culvert on Highway 71 into Wall Township; it's a well-worn path but really should be a sidewalk. Mayor O'Brien offered that it could be a combination of needing the State, Wall Township and Spring Lake Heights involvement. Mr. Corbeels stated that since the Borough is getting 2 new trucks, would the old ones be put out of service and not continue to put money into them. He inquired

how someone finds out about items previously brought up at meetings. Mr. Corbeels stated that he's brought up things and haven't heard anything. Mayor O'Brien explained some are budgeting decisions; he invited Mr. Corbeels to come to meetings during the budget process, Mayor O'Brien stated that quarterly the Borough Administrator does a quarterly report on ongoing projects. Mr. Diver added that some projects do extend over several months. Mayor O'Brien stated that the Borough doesn't own the street lights; Mr. Corbeels agreed that they are behind the times.

John Tangeman 564 Atlantic Ave reviewed that the canvassing ordinance states to apply at least 3 days prior to your requested canvas date and that the Chief of Police has 3 days to review. He feels this time frame should be reviewed so that you can apply and get your permit back in time for your date. He thought it could create an issue to review the application; maybe that should be changed.

Rachel Castellon Parkview Terrace stated that she was at Allaire Road Park and that the water faucet was running in the men's room and that there was no shut off. She added that the pipe travels to another room which there was no access to. John Tangeman announced that he had seen that as well, he added that he was there today and the faucet was removed. M. Shuler would speak to Public Works.
