Mr. Shuler – reported that DPW has found brush mixed in with leaves; the brush and leaves must be separate; also garbage & recyclables should be out by 7AM. A reminder that you can't use plastic bags for recyclables and snow season approaching, no parking on street during snow. Mayor O'Brien added that recycling rules are imposed by county – they are very strict with what they will collect; very expensive as well; also register for the alert to receive notice of snow-plowing.

Mr. Diver – no report

Mayor O'Brien reported that our tree-lighting is Thursday, December 6 at 7PM at Borough Hall. Also, there is a town holiday party on Friday, December 21 for volunteers & employees at Spring Lake Manor.

Mr. Diver – addressed Frank Cavaliere's comments on police contract – adding that he takes spending money very seriously; compared to last contract, it will now take officers 14 years (not 6) to get through their steps; officers will now be making about \$83,000 (not \$106,000) at end of 6 years, a significant reduction; we increased a clothing allowance; they also pay into their health care and will continue to do so. Contract is fair to both us and them; major difference was steps. We have a superior police department and want to keep that;. He also wanted to commended Z. Ramp, B. Shafer, E. Gunnell for their input and fairness in negotiations. We've saved money on retirements but have new-hires who will all be coming through at same time. We think of tax-payers first. SLH is a "full-time" town; residents live here year-round; we need a police force that is responsive to that fact. Mayor O'Brien added that he will make sure council has adequate time for discussion of contract. Mr. Cavaliere added that he wanted to make sure council looks at this big-ticket item thoroughly.

Mrs. King hasn't had enough time to read through contract; does like executive sessions in which council can discuss matters. Mayor O'Brien asked if tabling this will affect contract, which is for 2019 year. Mr. Collins thought no to his knowledge; added that contracts do not need to be adopted prior to year. He cautioned that placing contract on agenda and not acting on it is not something one likes to see with a collective bargaining negotiation. He added that not voting on something you don't know about is also a position to take. Mr. Diver stated that he noted in memo (in Friday's packet) that if anyone had questions, they should contact him; he received no call. Mr. Collins recommended that if it appears that council is not going to have enough votes to pass, not for the content of contract but for knowledge of it, that council does not have a motion that fails. Mrs. King wanted specifics. Mr. Diver gave specifics: we went from 6 steps to 14 steps; we went from a \$500 to an \$800 clothing allowance/year; we added \$100 to eyeglass benefit. Mrs. King wanted more time.

- Susan Lalji, of 559 Atlantic Ave., questioned assessment of her property; no one has ever come to see inside of her home since 2014; this year's assessment is \$52,000 higher than last year's. She has appealed several times; burdensome tax increase; time frame to appeal is narrow.
- Mr. Collins explained that local government has no authority over assessment of property in community; we are participating in assessment demonstration program of Monmouth County to try & get every property to be assessed at 100% of value; homes are grouped with like-properties. It is a state and county-controlled system; hard for assessors to get the balance right in smaller towns.
- Mayor O'Brien added that there are fewer homes for comparable data in a smaller town; most equitable way to do it is to make sure every home is assessed at as close to 100% of its value as possible. Faced with opting out of assessment program, there were many pitfalls. Assessor works with company doing on-site visits; whole town reassessed every year; likelihood is that homes in your neighborhood sold this year at much more than they would've last year. Best thing to do is to appeal; we have limited power as governing body; welcomed suggestions on improving program.
- Mr. Collins noted that problem in a rising market, there may be one or two good sales that skew the data; it's formulaic.
- Ms. Lalji suggested that company visiting should actually check all homes; see her kitchen compared to a new kitchen for example.
- Mayor O'Brien repeated our control is limited; would like it to be as fair as possible. Mr. Collins recommended speaking to assessor; concept of "functional obsolescence" exists when comparing homes of different ages.
