Margaret Melchione, of 2 Jeanette Ct., thanked Mayor for the meeting & the Environmental Commission for hosting public forums. She read a letter which is attached to petition with 300 signatures to restore trees to Allaire Rd. Park. (attached as part of minutes)

Maureen Miller, of 567 Monmouth Ave. asked if there is a resolution to exercise classes/recreation; Mayor & Mrs. Gillis explained we are gathering information in order to figure out best way to proceed with program.

Betty Cerkanowicz, of 411 8th Ave., stated we had a robust activity program at Community Center 15 years ago (bridge, library, exercise etc.) run by volunteers; she's asking to reconsider keeping activities for residents, in particular for those who do not live in Fairway Mews. Mayor responded providing these services is a great idea, need to make sure we handle it correctly.

Anna Kuntz, of 2205 Parkview Terrace, stated years ago we had a fantastic program of activities for seniors; she hoped to see more for seniors. Mr. Graetz stated that borough and the new recreation director are interested in building up program for all age groups, not just seniors, Erik is only on the job a few months, a work-in-progress; he appreciated the feedback. Ms. Kuntz also asked what generated need for Quiet Title Action; Attorney Collins explained we need deed to park to close out grant.

Karen Burke, of 606 Shore Rd., representing Shore Rd. community, read letter to council about maintenance around Wreck Pond: over-grown vegetation blocks view of water, dead trees, mosquitos/ticks, allergy issues, algae bloom, limited outdoor activities; asking grant application to include clean-up of entire length of Wreck Pond shoreline, east & west of Hwy 71; visual & physical access. Mayor responded we are applying for grant to address issues in this area. The letter is attached as part of minutes.

Richard Caunitz, of 5 6th Ave., thanked council for bringing the grant application forward; adding the pond is a great natural resource, he commended council for doing the work they do.

Kathy Kelsey, of 64 Jersey Ave., asked for a trash can on Shore Rd.; inquired if we had a beautification committee to decorate sign on way into town.

Margaret Melchione supports above speakers asking for more activities for seniors, library.

Anna Kuntz asked what's happening with Hwy 71 work by the shopping center; Mr. Campion explained making headway, area being cleaned up, next step is Transit, their pipe is undersized, a choke-point — water backs up there. Work still to be done, assemblymen helping.
