This is an opportunity to include local organizations and the school. Sandy Denison to look into dates at the Community Center.

b.) Proposed Ordinances (Nancy Maclearie Hayduk)

- 1.) Tree ordinance Nancy Maclearie Hayduk suggested each commission member speak directly to Council Members to discuss status and encourage the passage.
- c.) Parks Update (Lisa Ball-O'Brien)
 - 1.) EC formal recommendations progress EC to include water issue at the park on formal recommendations document. Water should be a focus of the early redevelopment of the park as it will help with the necessary watering of new plantings. Alex Burke was a suggested resource for this.
 - 2.) Committee Meetings Lisa Ball-O'Brien reported the Park Committee continues to meet. They will be recommending DPW get education on tree maintenance. Gaylen Nolan reported that there is a tree down in the Northeast corner of the park. Lisa Ball-O'Brien will contact Joe May, DPW Superintendent regarding this. 7.) New Business

a.) Recycling Event – Sandy Denison recently went to a Recycling event with a presentation from the County and sponsored by Lake Como Environmental Commission. She suggested the County should be invited to a town event. It was noted during the event that the biggest mistakes people make with recycling is recycling plastic bottles with attached caps, items (i.e. pizza boxes) with food contamination and recycling the wrong type of plastics. It was suggested that if there is any doubt throw it out. The mistakes cause additional labor and cost at the county recycling center. The Commission to encourage the town to be more conscious in paper use i.e. using recycled paper and recycled ink for the town-wide calendar.

8.) Voice of the Public

a.) Carol Maccanico from 557 Ocean Road. Carol suggested unclean recycling attracts critters. She expressed concern regarding the lack of trees at school. The commission to reach out to the school to ask the status of tree plantings at school and encourage additional trees to be planted
