1.) Call to Order, Pledge of Allegiance, and Open Public Meetings Notification

Gaylen Nolan reported that a member of the public dropped off a packet for a \$125,000 grant application, obtained from councilwoman Sara King, that the town is applying for to add new pickleball courts at Joseph E. Robertson park between the playground and Little League field. The EC reviewed the application and has the following questions: how was the money spent from the previous \$1M bond the town was awarded, is there usage justification for adding the courts, would the courts be better placed at Ocean Road park, where is the public hearing or notification on this proposal? It was suggested to contact Mayor Christopher Campion to discuss further.

Nancy Maclearie Hayduk provided an update on the new stormwater regulations, stating that if the state adopts the new stormwater regulations trees cannot be cut down without justification and replacement.

5.) Old Business

a. Reusable Bags Project & misc.

Local groups will be allowed to set up tables at National Night Out on the first Tuesday in August. EC to see if we can obtain materials to hand out (spotted laternfly info, temporary tattoos, etc.). The second annual SLH Fall Festival will be the weekend before Halloween; however, no local groups can participate. Nancy Maclear Hayduk suggested the EC try to be involved even if it is just to hand out information or man stations to increase awareness of the EC in town. Can the energy tips be added to the 2024 town calendar?

b. Energy Aggregation

Would SLH borough designate itself as an energy aggregator to SLH residents to purchase renewable energy?
