**Resolution of the Land Use Board of the Borough of Spring Lake Heights
Designating meetings of the Land Use Board
For 2024 and a portion of 2025**

WHEREAS, New Jersey Open Public Meetings Act (NJSA 10:4-8a et seq), requires that public bodies of a municipality designate and disseminate schedules, meetings, dates & times.

NOW, THEREFORE, BE IT RESOLVED, the Land Use Board of the Borough of Spring Lake Heights will meet on the second and third Wednesday of each month unless otherwise noted.
