AN ORDINANCE AMENDING CHAPTER 22, ATTACHMENT 3 MINIMUM OFF-STREET PARKING AND LOADING REQUIREMENTS

BE IT HEREBY ORDAINED by the Mayor and Council of the Borough of Spring Lake Heights in the County of Monmouth, State of New Jersey, that the Borough's Land Development Ordinance at Chapter 22, Attachment 3, Minimum Off-Street Parking and Loading Requirements of the Revised General Ordinances of the Borough of Spring Lake Heights is hereby amended as follows:

NOTE: Sections of Chapter 22, Attachment 3, Minimum Off-Street Parking and Loading Requirements that are to be amended are set forth below. All additions are shown in ***bold italics with underlines***. All deletions are shown in ***~~bold italics with strikeouts~~***. All sections that are unchanged remain in regular typeface.
